1. Deadline and Organizer

This giveaway is in no way associated with Instagram and is neither sponsored, supported, nor organized by Instagram. Instagram is not responsible for this giveaway and cannot be held liable in the event of complaints or disputes.

2. Who can participate?

Participation is open to students enrolled at a university within the jurisdiction of Studierendenwerk West:Brandenburg. These include the University of Potsdam, the Film University Babelsberg KONRAD WOLF, the University of Applied Sciences Potsdam, the Technical University of Wildau, and the Technical University of Brandenburg. Each person is allowed only one entry into the giveaway. Multiple entries or entries submitted after the deadline will be excluded. Studierendenwerk West:Brandenburg reserves the right to disqualify individuals who violate the terms and conditions or attempt to manipulate the giveaway process.

3. How to participate

The call for participation will be posted on the Instagram account of Studierendenwerk West:Brandenburg (<https://www.instagram.com/studierendenwerkwb/>). To successfully enter the giveaway, participants must like the giveaway post, tag a person they would like to go to the cinema with in the comments. Participation is possible during the giveaway period from November 03, 2025, to November 05, 2025. Entries are accepted from the time the post is published until 11:59 PM on the last day of the giveaway. Participation is free of charge, although costs may arise for internet access depending on the provider.

4. Prize

During the giveaway period, Studierendenwerk West:Brandenburg will 5x2 cinema tickets for the movie *Die Unfassbaren 3*.

Cash payouts for the prizes are not possible.

5. Winner Selection

Winners will be chosen by random draw and notified via private message within 7 days. The prize can only be claimed by those who verify their enrollment at one of the universities listed in Section 2 (e.g., by providing a university email address). Winners must respond within seven days, or a new winner will be drawn. Legal recourse is excluded.

c) Personal Data

d) Source

We collect personal data that you provide to us.

e) Purpose and Legal Basis of Processing

The data you provide and the data we collect are used solely for the purpose of conducting the giveaway and stored for this purpose (Art. 6 Para. 1 Sentence 1 lit. a, b GDPR). The data is used to record participants, determine winners, uniquely identify them, and notify them. No automated decision-making, including profiling, takes place. The prize draw is purely random. Data will not be processed for other purposes.

f) Necessity of Data Provision

Providing data is voluntary. However, participation in the giveaway is not possible without providing the required data.

g) Data Retention Period

Data collected as part of the giveaway will be deleted as follows:

- If you do not win: within 14 days
- If you win: within 30 days

h) Data Transfer to Third Parties

The giveaway takes place on Instagram. When visiting Instagram, your data is directly transmitted to Instagram. This may involve data transfers to the USA, over which we have no control.
