Declaration of consent Data protection within the framework of “Wohnen für Hilfe”

Dear students,

In order for us at Studierendenwerk West:Brandenburg to find a suitable housing partnership for you, we need some information from you. In accordance with the EU General Data Protection Regulation (GDPR), your written consent is required for the collection and processing of your data. You can give your consent to data processing on the next page of this document. First, we will explain why we need your data and how long we will store it.

What data do we request?

In addition to your personal details such as name, address, contact information, interests, and hobbies, we also ask about your studies. Furthermore, we ask for specific tenant information, general preferences regarding housing, and assistance. This data is important in order to find a suitable housing partnership for you.

How long do we keep your form and data?

We store your data for 12 months after it has been collected. If we have not been able to find a housing partner for you by then, we will contact you to ask whether you are interested in continuing the search process. If you are no longer interested, all your data will be deleted. In addition, your data will be stored for a further 6 months for possible queries. After that, all data will be deleted by Studierendenwerk West:Brandenburg. Reports and statistics for the evaluation of the project contain only anonymized information.

Who receives your data?

Your personal data will only be transferred to third parties for mediation purposes.

If a suitable match is found with a landlord,

If a suitable match with a housing provider is found, your application/cover letter (page 3) will be forwarded. If the housing partner agrees to an initial meeting, you will receive their contact information.

Can the data be revoked?

You can revoke the processing of your data at any time. In this case, mediation will no longer be possible. Revocation is also possible for an existing housing partnership, but in this case, further support from Studierendenwerk West:Brandenburg will no longer be possible.
